It's exciting for us to have new ideas, and new people who know we need to keep up the work of democracy even though the 2014 election is past. (We have the city and school board election coming in the spring and the new legislature will be presenting us with new issues for us to study and follow.) Be sure to introduce yourself to any with faces you don't recognize (or remember) so we can all be better acquainted.

We hope our new members as well as our old members will be at our general planning meeting on Jan 17 (see article elsewhere in this VOT-ER); we continue to have our LWV-WM monthly general meeting at Piccadilly restaurant on the 2nd Tuesday in Feb, March and April. We welcome all our newest League members.

After the New Year we will be organizing four committees for any member to be a part of if the particular topic is something you are interested in following. We hope these will be a place for **new members to mingle with other members** and all become better informed on a particular topic. The committee can then alert the rest of the League when an issue needs attention. These committees may meet as the need arises, mainly share info by email, or meet regularly as the committee members choose.

One of these new committees will follow the **education funding** issues that are coming in the 2015 legislature. The organization of huge corporate funders and legislators called ALEC

(American Legislative Exchange Council) has already written model bills to take more of our tax payer money away from public schools for private (even for-profit) schools and vouchers. Our committee will try to keep up with attacks on public school funding especially during legislature session. Megan Wright-Hagen and Barb Fuller are the conveners of this committee.

Another committee will be focused on voting issues. Even with the SAFE Act, the current voter ID and proof of citizenship voting law, in effect, I'm sure members know there are a number of alterations that may be able to get passed through the legislature to improve citizens' access to the vote. Mr Kris Kobach, the reelected Secretary of State, is intending to push the legislature to pass a law moving the prosecution of voter fraud to the Secretary of State's office. Currently, the county prosecutors are in charge (under the state Attorney General) or federal prosecutors. Another topic that has already been submitted in a bill proposes to move municipal and school board elections from April to the fall and perhaps make them partisan unlike now. If the topic of improved voting interests you contact Ernestine Krehbiel and Marilyn Chapman Hansen who will be the conveners of this committee.

The current LWV-WM two year local study committee on the local government budgeting process is already in place and will continue to bring information to the whole League. Anyone can join them. This certainly is going to be a timely issue since the city one-cent sales tax ballot issue lost so there will have to be decisions made as to how to fund water for the future, repairs of infrastructure, etc. Elaine Harvey and Carole Neal are the contacts for this.

Funding medical care in Kansas can be a fourth committee, watch-dogging KanCare and the impact of the lack of Kansas expansion of Medicaid or participation in the Affordable Care Act's state-run market exchanges. There seems to be interest in this topic for on-going League attention, so Allison Lemons will be the convener.

(Membership/Leadership/Development)

Our league participates in the National MLD program. It has come to our attention that a lot of our members are not aware of what this program is or how it works. To give you some information on the program we have included the following overview.

What is the MLD program? The Membership and Leadership Development
Program, sponsored by LWVUS, provides training to national and state
coaches and local teams as well as resources to increase membership and

to identify and develop new League leaders.

- **2.** What are the key components of the program?
 - Trained teams of 3 or more local Leaguers to communicate best strategies to the board for implementation
 - Support from a state coach, a national coach, and the national staff with resources
 - Use of the event planning checklist for all League events
 - Implementation of the best practices
- 3. What are the major best practices promoted by the program?
 - Always "ask" people to join at all League events
 - Create a welcoming environment at all League events
 - Follow up new members and attendees by asking them to come to events
 - Find out the interests of new members while orienting them to the League, tap into these interests to encourage participation
 - Increase visibility of the League throughout the year (even in the summer!) working with various media outlets, including the use of social media, enhanced website, direct contact with news personnel, etc.
 - Reach out to other organizations to partner with you
 - Develop an annual calendar of events that will attract a wider audience and develop programs and activities that connect with the community
 - Ask potential leaders to take

on small tasks and promote leadership development

- Tell our personal stories of what the League has meant to us, the League impact on individuals, through personal testimonies and written profiles
- And have fun! Social activities build relationships and involvement
- **4.** What if our League is already doing a lot of this? How will the program help?
 - Monthly coaching calls provide support, shares successes, and provides new resources
 - Training for your team members promotes leadership skills and commitment
 - New leadership in your League will need to be oriented to the program
 - Continuing the program institutionalizes the best practices, leading to organizational change and growth
- **5.** How long does it take for the program to result in change—new members and leaders?
 - The program is not a "quick fix" but requires ongoing effort and commitment from the local board. The program doesn't "end" but becomes the League "way."
 - Do not expect one or two people to implement the program. Get the entire board involved. Success requires total commitment!
 - The MLD team takes time to work together, build a rela-

tionship with the state coach, and learn how to implement the program through working with the board
